Direct Deposit Forms for Member Distributions

Please keep your banking information up-to-date with Finance. If you change your financial institution or have not yet provided any banking information to Finance, the following options are available to submit your Direct Deposit Information:

- 1. Mail in a sample VOID cheque from your chequing account that has your current address information on it. Please enclose a brief note such as "Please update my direct deposit information" and <u>sign and date</u> this note and provide your phone number in case we need to contact you.
- 2. If you have online banking, you can print out your own Direct Deposit form, <u>sign and date it</u>, print your address and phone number on it and mail it to FWFN Finance.
- 3. You can also visit your financial institution and have them fax FWFN Finance directly at (807) 623-5190 your direct deposit form after you signed and dated it. The fax must be faxed from the financial institution and cannot be faxed from a third-party fax number. Please note, some financial institutions provide this fax service and some do not. In the event they do not, you will need to mail this direct deposit form to us as we will require your **original signature**.
- 4. Please note Finance does not process any banking updates by email or pictures.

Youth turning 18 - Direct Deposit Forms

Please provide your direct deposit information as noted above at least 1-week in advance of your birthday. Please contact Ed Collins/Trustee directly relating to youth funds held in trust with the Specific Claim Housing Trust at (807) 623-2021 ext 602 or cell (807) 356-1970.

Late banking information - Annual Member Distributions

Any revised direct deposit information received after a member distribution will be processed on the 3rd-Friday of each month thereafter.

Are You Making a Payment?

Any member or customer making a payment (rent, ice rental, arena gym memberships, hall rental, hunting/fishing licenses, craft tables, Health Fair, Good Food Box, Pow Wow vendors, any other payments), Fort William First Nation Reception (2nd Floor of Band Office) must issue you an official pre-numbered FWFN receipt at the time of your payment.

FWFN Reception can now also process your payment by <u>debit/credit card</u> (Visa, MasterCard, American Express, and Discover).

FWFN Arena can process receipts if you are paying for your ice by cheque, debit or credit card. The Arena no longer processes cash. If you are paying your ice rental bay cash, please see FWFN Reception to have your official prenumbered FWFN receipt issued to you.

- 5. If you are providing your banking information for FWFN employee payroll purposes, you will need to consent to release this information from FWFN Payroll to share this information to FWFN Accounts Payable and you will need to sign and date this form along with FWFN Payroll sign off.

Christmas Boundary Interest Distribution

Further to the October 23, 2019 Chief and Council meeting your November 29, 2019 distribution details are as follows:

- \$500 per adult (aged 18 and older) member from the Boundary Trust Income Allocation
- \$35 per adult (aged 18 and older) member from the Boundary Trust Income Allocation
- \$50 for Elders aged 55-plus (at December 31, 2019) from the OFNLP funds

The above will be paid by EFT (electron funds transfer) and was uploaded to the RBC on Friday November 29, 2019. Funds may take up to 5-days to be deposited in your account so if you have not received your funds by Friday December 6, 2019 then please contact us at that time. Please contact Lori Payne, CPA, CA – Controller for these inquiries.

All payment are issued by EFT. The only exception is for those members who are not a resident in Canada. Non-resident members will be issued a cheque and it will be mailed to your last updated mailing address.

If your banking information has changed then you should refer to the first Finance page of our weekly Newsletter. We will require a new direct deposit form, please see the previous Finance page for the required format.

Members with Accounts Receivable

Further to the October 23, 2019 Chief and Council meeting, if members were in a receivable position based on your most recent accounts receivable statement that was provided to you (dated at October 31, 2019), your distribution was reduced up to 50% of your \$535 = \$267.50 depending upon the amount of your receivable balance owing to Fort William First Nation. The amount of reduction will be applied to the member accounts receivable balance owing and will be reflected in your new member statement balance at November 30, 2019 that will be provided to you by December 13, 2019.

Late banking information - Annual Member Distributions

Any revised direct deposit information received after a member distribution will be processed on a weekly basis until the Christmas break, each Friday. Please ensure your new banking information is received as soon as possible and no later than Wednesday each week before the Friday.

GAS CARD CHANGES

Effective January 1, 2020, the Ontario Gas Card will be discontinued

What is new as of January 1, 2020?

Instead of the Ontario Gas Card, First Nation people will be able to use their Indian Status card (Status card), which is issued by the Government of Canada, as proof of entitlement to buy gasoline exempt of Ontario gasoline tax.

First Nation individuals will be able to use the version of the card that they currently have in their possession (or may apply to the Government of Canada to obtain a Status card if they currently are not in possession of a Status card).

As proof of entitlement to buy tax-exempt gasoline at on-reserve retailers, First Nation individuals will use their:



Certificate of Indian Status Card with no renewal date: Secure Certificate of Indian Status Card: or

Temporary Confirmation of Registration Document.



Band councils, tribal councils, and band-empowered entities will use an Ontario issued unique identifier number issued by the Ontario Ministry of Finance.

Authorized retailers will no longer accept the Ontario Gas Card. The Ontario Ministry of Finance will no longer issue the Ontario Gas Card.

What does this mean for on-reserve gasoline retailers?

The Ontario Ministry of Finance (MOF) will be working with gasoline retailers in the months leading up to the January 1, 2020 effective date to ensure they are prepared.

Retailers who request refunds electronically from MOF will follow the same steps. Federal Status Cards will be validated at point-of-sale in near real time, and for valid cards, the transaction will be completed.

For those retailers who are filing manually, they may continue to file manually. There will be a new process implemented January 1, 2020 that is similar to the process they are currently using to file their claims. Ontario will help retailers transition smoothly to the updated process.

Is there a minimum age?

As of January 1, 2020, Children under 16 years of age will be able to use their own or their parent's Status Cards to purchase gasoline for their exclusive use (e.g. snowmobiles, ATVs).

Will individuals need a new federally issued card or can members use existing ones?

No, individuals are not required to obtain a new Status Card. They should be able to use the Status Cards in their possession to purchase gasoline exempt of gasoline tax.



Fort William First Nations Offices will be closed for the Holidays from December 20, 2019 and will resume business January 6, 2020. The following is a list of services and program information and how to access these during this closure.

Health: The Medical Van service will not be available throughout the holidays. Members will be responsible for their own transportation to their appointments. Taxi Slips will be issued to Thunder Bay Regional Health Science Centre ONLY. Please call the on-call phone at 472-7701. In a true emergency please contact 911.

Housing: Furnace calls – 633-3959 for emergencies only. Frozen Water Lines – Guy Collins at 472-3846 Power outages – Contact housing at 633-3959.

Public Works: Snow Removal – All public works crews are on standby. First priority is access roads followed by Elders Driveways.

Ontario Works: January 1, 2020's assistance will be distributed on December 30, 2019, all income statements should have been in no later than December 16th 2019. If you have submitted late you can expect your cheque on January 6th 2020.

Education: Living allowance will be deposited into participants accounts on the first banking day of the month in 2020

MAINTENANCE REMINDER

For Tenants & Homeowners

This is a reminder that the Fort William First Nation Administration Office will be closed for the holidays starting December 23rd and re-opening on January 6th.

The Housing On-Call (807) 633-3959, or the Housing Maintenance Supervisor (807) 472-8844, will be available in the event of an emergency. In order to prepare for the upcoming holiday closure, we would like to remind all tenants and homeowners to check their thermostat batteries and furnace filters.

Many of the calls we receive and respond to regarding furnaces can be a result of common problems that many homeowners oversee or are not aware about. This is a reminder to check these 3 components of your furnace before making a call to a service provider:

- The power supply switch looks identical to an ordinary light switch. Many times this switch accidentally gets shut off. Make sure the switch is in the ON position.
- Furnace filters may be clogged. A clogged filter will in fact shut down your furnace. Be sure to change your furnace filter every 1 3 months to keep your furnace running and in good shape.
- There are 2 types of thermostats. Mercury thermostats need to be level and fastened to the wall or they will not work properly. Check to make sure your thermostat is secure and level. Digital thermostats operate off the voltage in the thermostat wires. However, most run off batteries and you need to be sure to change them regularly for the thermostat to operate.

After checking these 3 components and your furnace is still not running, tenants are recommended to call the Housing On-Call Phone (807) 633-3959 so the Housing Department can initiate an emergency service call.

Home-ownership responsibilities include the regular maintenance, upkeep and repairs to the home and it's systems. The Housing Department works in close collaboration with the following 2 service providers:

Kemp Mechanical (807) 633-1288

Please note that it is expected that homeowners who arrange for the service providers also cover the costs associated with the service call.


