DO HEREBY RESOLVE:

WHEREAS: Fort William First is taking every effort to ensure the safety of its members and community members against the spread of the COVID-19 virus;

The Geographical location of the Fort William First Nation, being adjacent to the City of Thunder Bay, has become more vulnerable to the spread of the COVID-19 Virus with the frequency of vehicular and pedestrian traffic within the community;

AND WHEREAS: Fort William First Nation, shall exercise its right pursuant to section 81(1)(p) of the Indian Act to initiate A By-Law for the purpose of the protection of its members by the removal and punishment of persons trespassing on the reserve or frequenting the reserve for prohibited purposes;

AND WHEREAS: Pursuant to section 81(p) of the Indian Act, Fort William shall have enforced a trespass order as a measure to protect the community.

THEREFORE, BE IT RESOLVED THAT: Pursuant to section 81(p) of the Indian Act, Effective Wednesday March 25, 2020, Fort William First Nation hereby initiates a Trespass order against all vehicular and pedestrian traffic between the hours of 8:00 p.m. to 6:00 a.m. within it's boundary property accessed from City Road, Chippewa Road and Mountain Road, Thunder Bay, Ontario.

BE IT FURTHER RESOLVED THAT: Anishinabek Police Services shall enforce such Trespass Order with the right to remove from Reserve Property those who violate such order.

BE IT FURTHER RESOLVED THAT: This by law shall be in effect until such time that the Chief and Council of Fort William First Nation rescinds this By-Law by motion.
