#### **Christmas Boundary Interest Distribution**

Chief and Council have approved the annual distribution to be made on December 2, 2021 based on the Band Membership list of November 1, 2021 as follows:

- \$600 per adult (aged 18 and older) member from the Boundary Trust Income Allocation
- \$50 for turkey per adult (aged 18 and older) member from the Boundary Trust Income Allocation
- \$50 for Elders aged 55-plus (at December 31, 2021), plus a one-time \$50 in lieu of the party, from the OFNLP funds

The above will be paid by EFT (electronic funds transfer) and will be uploaded to RBC on Thursday, December 2, 2021. Funds may take up to 5-days to be deposited in your account so if you have not received your funds by Thursday, December 9, 2021 then please contact Esther Pervais, Finance Officer.

If your banking information has changed then you should refer to the first Finance page of our weekly Newsletter. We will require a new direct deposit form, please see the previous Finance page for the required format.

Any revised direct deposit information received after a member distribution will be processed on a weekly basis until the Christmas break, each Friday. Please ensure your new banking information is received as soon as possible and no later than Wednesday each week before the Friday.

#### **PAYMENTS BY CHEQUE**

For those members who are not a resident in Canada, cheques will be automatically issued and mailed to your last updated mailing address.

Members who do not have a current bank account and would like to request a payout by cheque will have to submit their request by emailing or calling the main reception line at <a href="reception@fwfn.com">reception@fwfn.com</a> or 807-623-9543. Finance will not be able to process these cheques until the week of December 6, 2021 and cheques will take 4-5 business days to process from when the request is received. Cheques will be available for pick-up from reception only after you receive a call that they are ready.

#### NOTICE TO COMMUNITY- Update on COVID-19 from Emergency Response Group

Effective Immediately Fort William First Nation offices will be closed. FWFN Staff have been following all COVID 19 protocols. However, as a precautionary measure all offices will be fully sanitized before staff will return to work. The office will be closed until further notice.

As of November 26, 2021, there are 7 confirmed cases of COVID 19 in the Fort William First Nation Community. The Emergency Response Team has responded and will continue to follow up in this situation. Please keep in mind our community has many vulnerable people, including children under 2 who are not yet able to be vaccinated. In many homes there are multiple families living together that can create conditions for greater community spread of the virus.

Please continue to stay safe. We are all in this together as a community and we will get through this as a community.

# In response to the recent outbreak of COVID-19 at a local school,

Fort William First Nation is once again urging members to use.

"COVID-19 COLOUR CODED FLAG SYSTEM"

The system is an emergency measure, for those who are sick or self-isolating to indicate that help is needed.

It isn't intended to replace communication with essential service providers, but to serve as a backup measure.

It is the responsibility of the homeowner to ensure that they have the essential items that they need in their homes such as food, medications etc.

In the event that you or someone in your home has tested positive for COVID-19 or has been identified by the Thunder Bay District Health Unit as a close contact of someone who has tested positive for COVID-19 and is in self-isolation, please ensure that the color-coded flag is placed in a spot that is visible from the road or driveway, such as a living room window.

#### NOTICE TO COMMUNITY- Electronic Voting

Our Chief and Council have approved our voting system to move toward electronic voting for upcoming vote requirements. With this direction, Fort William First Nation will be working with OneFeather (onefeather.ca) to set up online electronic voting and community engagement solutions. The upcoming votes to use OneFeather technology will be:

- FWFN Specific Claims Housing Trust Youth Trust Payments
- FWFN Lands Code

This will allow more accessibility for band members to participate in our governance and will represent our First Nation moving toward with modern technology. Band members will be required to create a OneFeather profile following the steps below. Setting up your profile is easy, safe and your personal data is secure and protected. It will only take a few minutes to complete this process. Other traditional paper voting solutions will remain in place for those members who do not have access to smart Edevice technology (phone, tablet or computer) and who may not have a personal email address.

OneFeather has set up a quick engagement event to get you started and activate your profile. You will require a personal email address, your status card number and date of birth. Click the RED button at the link below. Click the RED button - you will be guided through the activation process – it should only take a minute or two.

- When someone dials 911 for any medical emergency, the First Response Team will be called in additionally with Superior North EMS. This means that First Responders will usually arrive on scene prior to an ambulance or a fire truck;
- First Responders will clearly identify themselves and will announce themselves when they arrive to your location;
- First Responders are trained individuals who can provide medical assistance to individuals who are experiencing a medical emergency. First Responders are trained to Provincial standards by the Ministry of Health.

We are excited to start providing services to the community and deploying our resources to help mitigate the potential loss of life from the extended wait times for an ambulance. Aside from providing emergency services to the community, the Fort William First Nation First Response Team will be providing a list of other services to promote health & safety awareness which more information can be found on our website (fwfnfirstresponse.com).

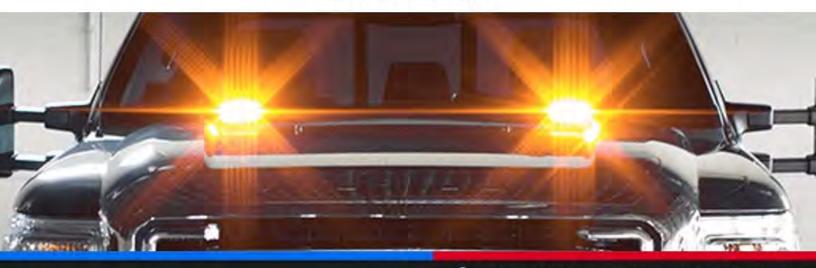

The Fort William First Nation First Response Team would like to notify community members and visitors that the First Response Team will be using flashing amber lights when responding to emergency calls within the community.

If you see a vehicle approaching behind you with flashing amber lights in the community, follow these steps!

- 1. If you are at a stop sign, allow the vehicle with flashing amber lights to continue first when safe to do so;
- 2. If the vehicle is approaching from behind, yield the right of way and pull over to the side of the road when safe to do so to allow the vehicle with flashing amber lights to pass safely. Using your turn signal to show when you are pulling to the side of the road is an indicator for First Responders to safely pass;
- **3.** If you are unable to yield the right of way due to traffic, continue to drive as usual until it is safe to yield the right of way.

Allowing vehicles with flashing amber lights to pass you when it is safe to allow them to pass will allow our First Responders who are responding to an emergency medical call within the community to arrive more rapidly. This is a courtesy and is greatly appreciated by the First Response Team! Help save lives and yield to flashing amber lights!

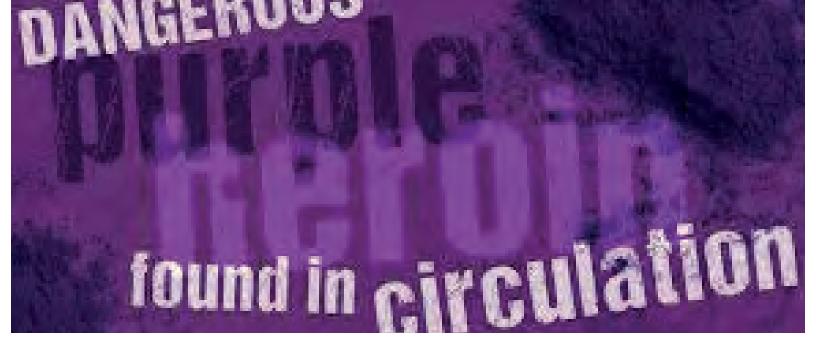

The city of Thunder Bay is experiencing an alarming amount of overdoses this past weekend from the synthetic drug "purple down".

### WHAT IS IT?

Purple down is a mix of fentanyl, carfentanyl, heroin, and is often cut with benzodiazepines.

Purple down can have different variations and it can have other names such as 'pink dizzy' and 'blue down

# WHAT HAPPENS?

Causes severe respiratory depression and can lead to death. When purple down is laced with benzodiazepines, it slows down a persons breathing leaving individuals severely unconscious, gasping if breathing at all.

#### **WARNING:**

Fort William First Nation and the region of Thunder Bay has reported a batch of purple down that is causing overdoses and death.

### **Thunder Bay Police Report Increase in Overdoses**

Thunder Bay Police have alerted us that they have seen a spike in overdoses over the weekend and some have resulted in death.

Use of an opioid commonly referred to as "pink down" or "pink dizzy" is suspected, but other substances may also be a cause of the increase.

Signs of opioid toxicity include impaired breathing, loss of consciousness, inability to talk, blue fingernails or lips, or loud snoring or gurgling.

People who use drugs can <u>reduce the risk of harm</u> from fentanyl and other opioids by:

- using drugs in the presence of others (supervised consumption service open daily 10am-6pm @ NorWest CHC Thunder Bay Site), or arranging for someone to check in on them;
- avoiding using drugs at the same time if using in a group;
- trying a small amount before using their usual amount;
- calling 911 if someone develops signs of opioid toxicity; and
- carrying naloxone (available for free from the Health Unit [621-7861] and most community pharmacies).







#### TBDHU Advising against non-essential travel to Minnesota and other nearby states

At this time, the Thunder Bay District Health Unit (TBDHU) is recommending that all residents avoid non-essential travel to Minnesota, Wisconsin and Michigan. This is regardless of an individual's vaccination status. These states currently have the highest rates of COVID-19 in the United States and the rates are considerably higher than those in the TBDHU area. In addition, public health measures are also different in these areas and are generally looser than those in TBDHU and Ontario. This contributes to higher levels of community transmission and greater risk to people.

"While border restrictions are relaxing, we need to recognize that travel can pose a risk, especially travel to areas where case numbers and community transmission are higher," says Dr. Janet DeMille, Medical Officer of Health. "Recent cases in our area acquired the infection in nearby states. It is strongly recommended that individuals who travel continue to follow all public health measures to reduce their risk."

If residents do plan to travel to these areas, it is recommended they check the <u>travel guidance</u> on the TBDHU website for information on how to stay safe while travelling and for information on what to do once they have returned.

When individuals return to this area, it is particularly important to monitor for symptoms and if any symptoms develop, immediately self-isolate and arrange for testing.

As of November 30, the requirements for returning to Canada after short trips to the United States have changed. To check if you qualify as a fully vaccinated traveller, please visit the Government of Canada <u>travel website</u>. Note that upon re-entry to Canada, children under 12 cannot attend school or daycare for 14 days, and should limit contact with others for the same time period.

TBDHU encourages everyone, whether you have been vaccinated or not, to continue following all <u>public health measures</u> to protect the health of individuals and our health system. If you develop any COVID-19 <u>symptoms</u>, even mild ones, isolate immediately and arrange to get tested at your local <u>assessment centre</u>.

These case studies will serve to broaden conversations about climate policy recommendations from an Indigenous lens. Successful recipients will receive a stipend of \$15,000 to complete their research. The Canadian Institute for Climate Choices is an independent research institute with a commitment to provide policy advice based on sound, credible and inclusive research. We aim to integrate research on adaptation, mitigation, and clean growth to support more effective climate policy outcomes.

The Institute focuses on providing practical, evidence-based advice on policy that can advance the country toward a future that is low-carbon, resilient to a changing climate, prosperous, and inclusive. The Institute is committed to ensuring that its work supports Indigenous self-determination and that Indigenous ways of knowing, being, and doing strengthen our future policy recommendations. The Institute recognizes that this work must be led by and for Indigenous Peoples. Historically, research in Indigenous communities and Northern communities has neglected the expertise of Indigenous Peoples. We want to amplify Indigenous voices, research, and worldviews to ensure that our research meaningfully and inclusively embodies First Nation, Métis and Inuit perspectives. The Institute has partnered with the Centre for Indigenous Environmental Resources (CIER), a First Nation-directed national non-profit environmental charitable organization, to provide support to Indigenous researchers throughout the case study development process.

In particular, the Institute and CIER want to profile successes and lessons learned through case studies of Indigenous experience with respect to climate change, climate injustice, climate change policy, and clean growth. These case studies should be firmly rooted in specific times and places, and should contain and explore particular events, policies, or communities in detail. They should also demonstrate insights that can be applied in other contexts or to broader policy design.

Our organization invites interested **Indigenous researchers**—including but not limited to **independent researchers**, **Knowledge Holders**, **PhD and Postdoctoral researchers**, **and consultants**—to submit abstract proposals highlighting climate policy lessons specific to

Indigenous communities across adaptation, mitigation and/or clean growth perspectives. Where possible, we encourage applicants to draw on traditional knowledge, two-eyed seeing or Inuit Qaujimajatuqangit. Case studies should be as narrowly scoped as possible and should seek to explore impacts, implications, and experiences connected to climate change, climate justice, and climate policy in specific times and places.

Each applicant will work with CIER and CICC staff, advisors, and Expert and Knowledge Holder Panelists in their area of interest (mitigation, adaptation, or clean growth). These abstracts can either be related to work that is underway (connected to a PhD or post-doc) or original research. Selected candidates will have their case study published on the Institute's website.

While we are open to a wide range of potential case study topics within these parameters, we are particularly interested in case studies that align with current research underway at the Institute, including:

- Low-carbon transition initiatives, particularly for the 2021-2030 period (mitigation)
- The costs and impacts of climate change and initiatives to minimize those costs and impacts (adaptation)
- Risks and opportunities for Canada and the competitiveness of Canadian and Indigenous businesses in the global transition to a low-carbon economy (clean growth)

We are also particularly interested in case studies that explore gaps in our research, including:

- Indigenous governance models that could inform the larger <u>Climate Accountability</u>
   <u>Framework</u>, or ideas for how the framework could best uphold Indigenous rights and
   meaningfully engage Indigenous peoples as partners in the process
- Intersectional climate change issues (e.g. gender diversity and inclusion, racism and climate change, food sovereignty, food security, biodiversity and climate research)
- Renewable energy generation in remote Indigenous communities (e.g., displacement of diesel fuel).

We encourage multi-media, storytelling and other creative ways to communicate the results of case studies and lessons learned to a broader audience.

Chosen applicants will receive a research stipend of \$15,000 to be allocated in two installments. This is a competitive process. Up to four applicants will be selected in this second call.

#### **Submission Materials:**

- Please select the area(s) of climate policy research to which your proposed case study is most connected: clean growth, mitigation, adaptation (integration across multiple areas will be considered a strength).
  - Abstract—Abstracts should be no longer than one page (Times New Roman, Font Size 11, Single spaced) and may include references (no longer than an additional page). Please detail which area you are applying for and provide an outline of your intended research.
  - 2. **Letter of Introduction**—Please include a one-page letter of introduction so that we know who you are. This is an opportunity for you to let us know where it is that you come from and get to know you better through your story.
  - 3. Ethics Approval—If the research involves human subjects and/or fieldwork, applicants should submit verification of ethics approval from the community/region (if applicable) and their institution's Research Ethics Board. Research must demonstrate that it follows <a href="Tri-Council Policy Statement Chapter 9">Tri-Council Policy Statement Chapter 9</a>. If you are conducting scientific research that requires ethics approval, documentation must also be provided. If ethics approval has been sought but not yet received, please include documentation.
  - 4. **CV/Resume** Please include the most recent copy of your CV or resume.

All submission materials should be compiled in a single pdf document in the format (Last NameFirst name\_Area of Interest\_Date.pdf). This ensures that no materials will be missing for the adjudication review committee. Area of Interest would be Clean Growth, Mitigation or Adaptation.

#### **Case Study Deliverables:**

Case studies should be 5-8 pages (Size 11 font, Arial) of content plus references. These should include secondary sources. Case studies can be written in French or English. Should you also wish to translate the case study into an Indigenous language, this is an option (to be discussed with the Institute research staff). We encourage the provision of additional context in appendices such as photos, storytelling, maps, etc.

Regular check-ins will take place with CIER and the Institute staff liaison on an as-needed basis.

Suggested Case Study Template

- 1. Abstract (1-2 paragraphs that summarize your case study)
- 2. What is the issue/problem/challenge?
- 3. How does this issue connect to climate change or climate change policy?
- 4. What insights emerged from this experience or this issue?
- 5. What lessons learned might be relevant in other communities/jurisdictions/context, or what policy recommendations might be offered to one or more orders of government?

Deadline for Abstract Applications: Wednesday, January 5, 2022, @ 4 pm CT.

#### **Application Process:**

All abstracts will be adjudicated by **January 10, 2022**, and all selected candidates will receive a response by January 14, 2022. At this time a primary meeting will be coordinated for the following week of January 17-21. Abstracts will be adjudicated by CIER and Climate Choices.
