



UTV (side by side) and ATV rules and Regulations

KNOW your rules of the road for both off road use and road use.

All operators must possess a driver's licence to operate on roadways. Vehicle must be plated and insured. Driver and occupants must be wearing proper DOT approved helmets which are properly fastened. UTV on road, occupants must wear seat belts provided.

OFF ROAD RULES

- Drive off road vehicle no permit or no plate 3(1) ORVA fine \$85.00 plus costs total \$110.00
- Permit child under 12 to drive off road vehicle section 4(1) ORVA fine \$85,00 plus costs total \$110.00
- Use unauthorized plates or permit use of unauthorized plates section 9(1)(d) ORVA fine N.S.F (no set fine – court appearance)
- Off highway - Drive off road vehicle – no insurance section 15(1) ORVA or permit off road vehicle to be driven – no insurance section 15(2) fine \$260.00 plus costs total \$325.00
- Careless driving section 16 fine \$160.00 plus costs total \$200.00
- Fail to wear proper helmet section 19(1) ORVA fine \$85.00 plus costs total \$110.00
- Fail to securely fasten helmet chin strap section 19(1) ORVA fine \$85.00 plus costs total \$110.00
- Fail to stop – flashing red and blue lights section 18(1) ORVA fine \$150.00 plus costs total \$180.00

ON ROAD\HIGHWAY RULES

- For UTV operating on roadway. No seatbelt or non compliant seat belt section 10.1(3)(b) HTA O.REG 316/03 fine \$260.00 plus costs total \$325.00
- For UTV and ATV Drive no Helmet section 19(1) HTA O.REG 316\03 fine 260.00 plus costs for a total of \$325.00
- On highway for UTV and ATV drive not properly insured section 17 HTA O.REG 316\03 fine 400.00 plus costs for total of \$490.00
- On highway for UTV and ATV No driver's licence section 18(1) HTA O.REG 316\03 fine \$260.00 plus costs for a total of \$350.00
- For ATV and UTV on roadway - Fail to drive on shoulder section 24(1) HTA fine \$85.00 plus costs total \$110.00
- For UTV and ATV - Speeding more than 20km\h where limit is 50km\h or less fine \$120.00 plus costs total \$150.00 section 22(a) HTA O.REG 316]03
- For UTV and ATV - Speeding more than 50km\h where limit is 50 km\h or more fine \$120.00 plus costs for total of \$150.00 section 22(b) HTA O.REG 316\03

It is the Driver's responsibility to know the rules of the road. Check you OFF Road Vehicle Act and your Highway Traffic Act for further offence
